Normal application procedures for this product pose no hazard as to the release of crystalline silica dust, but grinding or sanding dried films of this product may yield some respirable crystalline silica. Chronic Effects:

Carcinogenicity: Crystalline silica in the form of quartz or cristobalite dust causes cancer of the lung.

<u>Titanium dioxide</u>:

Chronic Effects:

Normal application procedures for this product pose no hazard as to the release of respirable titanium dioxide dust, but grinding or sanding dried films of this product may yield some respirable titanium dioxide. Although IARC has classified titanium dioxide as possible carcinogenic to human (2B), their summary concludes: "No significant exposure to titanium dioxide is thought to occur during the use of products which titanium dioxide is bound to other materials". OSHA does not regulate titanium dioxide as a carcinogen. However, under 29CFR 1910.1200 the SDS must convey the fact that titanium dioxide

is a potential carcinogen to rats.

Carcinogenicity: Animal evidence shows that high concentrations of pigment-grade (powdered) and ultrafine titanium dioxide dust caused respiratory tract cancer in rats exposed by inhalation.
